### **Redflex Holdings Limited – 2020 Annual General Meeting**

### **Business of the AGM**

As a shareholder, you can attend and vote online at the meeting and as a proxy for another shareholder using your smartphone, tablet or computer.

*Online Registration for Shareholders*

Online registration for the meeting will be open from 8:00am (AEDST) via the Lumi platform at <http://web.lumiagm.com/307138806> or by downloading the Lumi AGM app from the Apple App or Google Play Stores by searching Lumi AGM.

*Assistance with Online Shareholder Registration and Appointed Proxy Holders*

Assistance with online registration for the meeting will be open from 8:30am (AEDST) by calling Computershare Investor Services on +61 3 9415 4024. Computershare Investor Services will also provide usernames and passwords to appointed proxy holders using this same telephone number.

If you are unable to attend the online AGM in person, you may wish to appoint a proxy to attend and vote at the AGM in your place. Shareholders are encouraged to lodge a directed proxy online at [www.investorvote.com.au](http://www.investorvote.com.au) using your six digit control number. Alternatively, a directed proxy may be lodged by mail or fax. Proxy forms must be lodged by 9:00 am (AEDST) on Saturday 28 November 2020. Please see the Notice of Meeting for further details on lodging a proxy form.

Shareholder questions should be submitted prior to the meeting and should be received by the Company by 5:00pm on Thursday 26 November (AEDST).

*Questions at the AGM*

Despite the above, shareholders may still ask questions at the AGM itself, using the online webcasting platform. This will ensure that all persons entitled to attend the meeting and to ask questions have a reasonable opportunity to participate in a meaningful way at the meeting.
